What is this product?

Objectives:


The fund seeks to earn income and preserve the value of your investment by investing mainly in a variety of high quality deposits denominated in Euro and fixed-income securities (bonds that pay fixed interest rates of short duration).

Intended retail investor:

This product is intended for investors who are prepared to take on a relatively low level of risk of loss to their original capital which tends to result in a lower potential return. It is designed to form part of a portfolio of investments. This type have experienced low rises and falls (volatility) in value in the past.

What are the risks and what could I get in return?

Risk Indicator
