What is this product?

Objectives:

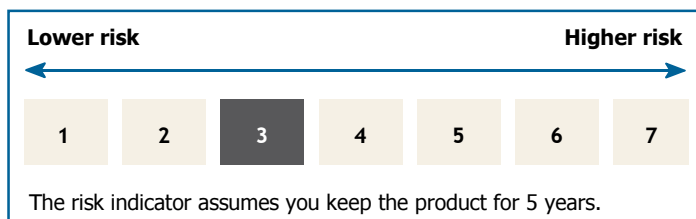
The fund seeks to achieve sustainable income and modest growth of your investment by investing mainly in bonds (and other debt securities) that are issued by governments, supranational bodies and companies worldwide.

Intended retail investor:

This product is intended for investors who are prepared to take on a moderate level of risk of loss to their original capital in order to get a higher potential return, and who plan to stay invested for at least 5 years. It is designed to form part of a portfolio of investments. Funds of this type have experienced average rises and falls (volatility) in value in the past.

What are the risks and what could I get in return?

Risk Indicator



The actual risk can vary significantly if you cash in at an early stage and you may get back less.

What happens if Christian Brothers Investment Services, Inc. is unable to pay out?
